### ATTACHMENT/COMPLETENESS REVIEW

IN ORDER FOR THE NRAC TO SCORE A PROJECT AND AWARD FUNDING, THE PROJECT APPLICATION MUST CONTAIN EACH OF THE ITEMS LISTED BELOW AS THEY RELATE TO THE PROJECT. IF THE NRAC DEEMS THE PROJECT INELIGIBLE THE PROJECT WILL NOT BE SCORED AND WILL NOT BE AWARDED FUNDING. (ORC 164.23)

1. A certified copy of the authorization by the governing body of the applicant authorizing a designated official to sign and submit this application and execute contracts with the commission. This individual should sign under 6.0, Applicant Certification.
2. A certification signed by the applicant's chief financial officer stating all local share funds required for the project will be available on or before the dates listed in the Project Schedule section. **If a non-local source, an entity other than the applicant, provides funding towards the project, a letter of commitment from the non-local entity source must be submitted with the application.** (ORC 164.23 (B)(2))
3. A cooperation agreement, (if the project involves more than one entity) identifying the fiscal and administrative responsibilities of each participant.
4. Resolution(s) of Support. (ORC 164.23)
  - a. As per ORC 164.23 (C), an applicant that is a park district or other similar park authority must provide documentation of consultation with consult with the legislative authority of each county, township, and municipal corporation in which the proposed project will be located.
5. Each project must provide the following aerial maps **CLEARLY** showing/identifying: (ORC 164.23 (A)(3))
  - a. Aerial map of the project clearly identifying the project boundary.
  - b. Project location with respect to its location within the county/township/municipality.
6. **For Land Acquisition Projects:** Applicants MUST provide documentation of either a Signed Purchase Agreement or Letter of Intent to Sell. (ORC 164.23 (A)(10))

**For Restoration Projects:** Applicants **MUST** provide:  
(ORC 164.23 (A)(10))

- a. Documentation of preliminary plans by a licensed: landscape architect, engineer, or other qualified professional.
  - b. Documentation of Secured Appropriate Permits or Permitting Process.
  - c. Provide an itemized engineer's (budget) estimate for proposed restoration work.
7. Project Schedule. (ORC 164.23 (A)(12))
  8. Proposed Declaration of OPWC Restrictions; also include other restrictions.
  9. **For Acquisition and/or Conservation Easement Projects: An appraisal report OR restricted appraisal report is due at the time of application.** Applications with a purchase price that is more than 5% above the appraised value must show that local share is meeting the additional costs. Justification must be provided to the District Six NRAC for any acquisition above the appraised value.

**\*\*PLEASE REVIEW THE DISTRICT SIX NRAC'S SCORING METHODOLOGY TO ENSURE YOU ADDRESSED ALL APPLICATION COMPONENTS. - 2) Aerial view maps(s)<sup>3</sup> of project indicating: (*ORC 164.23 (A)(3)*)
  - Major roadways
  - Major/Minor Streams
  - Floodplains
  - Wetlands
  - Other permanently protected lands. If part of a phased or an expansion of a previous Clean Ohio project (s), indicate current project with relation to previous project(s).
- 3) Conceptual Site Design indicating: (*ORC 164.23 (A)(3)*)
  - Public access point(s);
  - Proposed Parking area(s)
  - Proposed trail(s); and
  - Other eligible improvements.

If improvements, such as trails, parking, etc., are not feasible and/or not applicable to the project, the applicant must, at a minimum, provide a map showing where access to the project is provided
- 4) For restoration projects include items 1-3 from above and the following Conceptual Site Design information indicating: (*ORC 164.23 (A)(3)*)
  - Stream/wetland project boundary;
  - Tributaries;
  - Riparian area;
  - Location of and description of restoration activity(s),
  - Location of and description of revegetation activity(s);
  - Proposed public access point(s);
  - Proposed trail(s); and
  - Other eligible improvements.
- 5) Project location with respect to the OH-PA 2010 Urbanized Area, if applicable.<sup>4</sup>
- 6) Identification of any participation by agencies or organizations that may have expertise regarding the project and may provide assistance with respect to the project.
